Who We Are

Scotts Valley Educational Foundation (SVEF) is a community-based nonprofit organization that builds public support and raises resources for quality educational programs at all four Scotts Valley Schools.

Our supporters include businesses, parents, educators, students and community members who care about the education of our young people.

Our Story

Founded in 1983 in response to the negative effects of Proposition 13 on public school funding, SVEF was established to provide funds for district-wide programs.

In 2009, the Foundation began contributing to an Endowment Fund to create a constant source of income. For every dollar raised, 15% is contributed to the Endowment. Today, the fund is valued at over \$260,000.

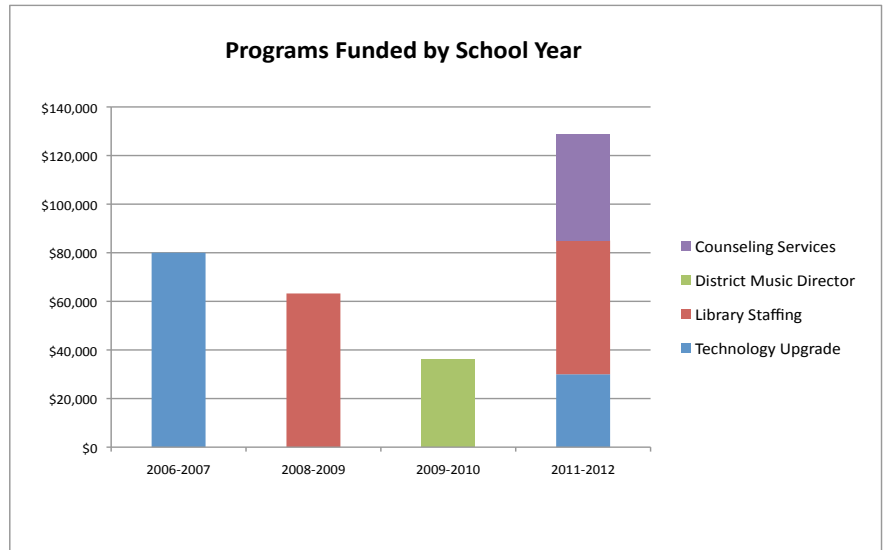

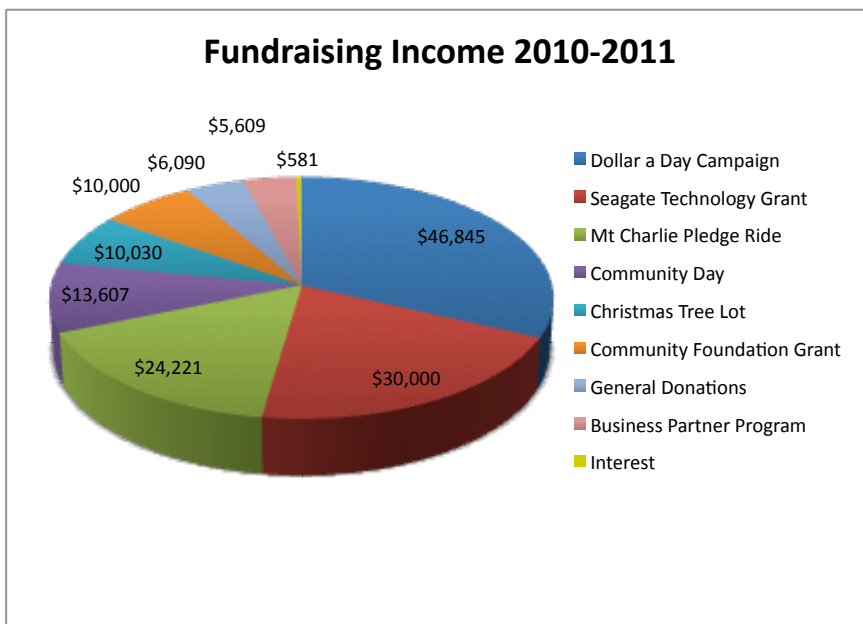


Programs We Support

Our board meets regularly with district officials to determine the highest priorities of the schools and votes annually on which programs to fund.



Fundraising Income



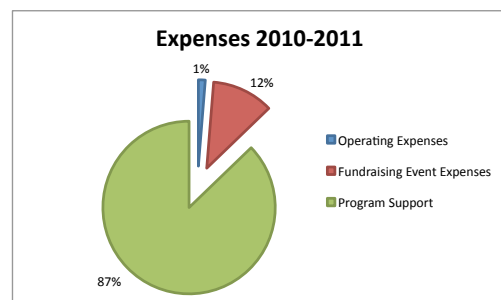
